**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Termination"), dated as of July 11, 2023, is executed by TRINITY CAPITAL INC., a Maryland corporation ("Lender"), in favor of Exer Holding Company, LLC, a Delaware limited liability company ("Debtor"). All capitalized terms used in this Termination and not otherwise defined herein, shall have the respective meanings given to such terms in the Security Agreement (defined below).

RECITALS

A. Pursuant to that certain Intellectual Property Security Agreement, dated as of November 19, 2021 (as amended, the "Security Agreement"), by and between Debtor and Lender, Debtor granted to Lender a security interest in the Intellectual Property Collateral (as defined in the Security Agreement).

B. The Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office at Reel 7502, Frame 867.

C. Lender agrees to execute this Termination in order to evidence the termination and release of its security interest in the Intellectual Property Collateral, including, but not limited to the Trademarks listed on Exhibit B attached hereto.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Lender hereby agrees as follows:

(a) Lender expressly terminates and releases all of Lender's right, title and interest in, to and under the Intellectual Property Collateral.

(b) Lender represents and warrants that it has the full power and authority to execute this Termination.

(c) Lender authorizes and requests the trademark divisions of the United States Patent and Trademark Office, and the United States Copyright Office, to record this Termination.
