TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement is effective as of June 29, 2022 (the “**Effective Date**”) by and among by and between Anchorage Capital Group, L.L.C., a Delaware limited liability company having an address of 610 Broadway, 6th Floor, New York, New York 10012 (“**Assignor**”), and Anchorage Advisor Holdings, L.P., a Delaware limited partnership having an address of 610 Broadway, 6th Floor, New York, New York 10012 (“**Assignee**”).

WHEREAS, following a Trademark Assignment Agreement effective June 29, 2022 between Anchorage Capital Management, L.L.C. and Assignor, Assignor is the sole owner of certain trademarks and designs related to the use of the name “Anchorage,” including without limitation the trademark registrations for such marks and designs as set forth in Exhibit 1 hereto, together with all common and civil law rights in the marks set forth therein as well as all goodwill associated therewith and symbolized thereby (collectively, the “**Trademarks**”); and

WHEREAS, Assignor has agreed to transfer to Assignee all of Assignor’s right, title, and interest in the Trademarks in the United States and throughout the world.

NOW, THEREFORE, in consideration of and for the promises and covenants set forth herein and for other good and valuable consideration (including without limitation the promises and mutual covenants set forth in the Letter Agreement between the parties effective June 29, 2022), the receipt and sufficiency of which are hereby acknowledged, Assignor agrees, effective *nunc pro tunc* as of the Effective Date, to assign and hereby assigns, transfers, and conveys to Assignee, and Assignee’s successors and assigns, all of Assignor’s right, title, and interest throughout the world in, to, and under the Trademarks together with:

- (i) all common and civil law rights therein; and
- (ii) the goodwill of the business connected with the use of and symbolized by the Trademarks.

The foregoing assignment includes without limitation any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on and/or after the date hereof, including without limitation all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, together with the right but not the obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages. The foregoing assignment also includes all copyrights associated with the designs or logos included in the Trademarks.

Assignor hereby authorizes and requests the Commissioner for Trademarks of the United States Patent and Trademark Office, and any official of any other country or countries foreign to the United States whose duty it is to issue trademark registrations as aforesaid, to issue any registrations to Assignee, and Assignee’s successors and assigns, as assignee of the entire interest herein assigned.


Assignor agrees to provide its full cooperation and assistance to Assignee in connection with this Trademark Assignment Agreement, including without limitation by executing and
