TRADEMARK ASSIGNMENT

RECITALS

WHEREAS, in connection with that certain Asset Purchase Agreement dated February [17], 2023 between Assignor and Assignee (the "Asset Purchase Agreement"), Assignor agreed to assign to Assignee all of Assignor's right, title and interest in and to the trademarks and the registrations and applications therefor listed on the attached Exhibit A ("Trademarks"), including the goodwill of the business associated therewith and the right to sue for, recover damages and relief for, settle, or release any past, present or future infringement, dilution or violation of the foregoing;

WHEREAS, Assignee desires to obtain, and Assignor has agreed to assign, all of Assignor's right, title and interest in the Trademarks according to the terms of this Assignment.

NOW, THEREFORE, for one dollar (\$1) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignment. Assignor hereby sells, assigns, transfers and conveys to Assignee, its successors, assigns and legal representatives, all right, title and interest throughout the world in perpetuity in and to the Trademarks and all common law rights and goodwill of the business associated therewith and the right to sue for, recover damages and relief for, settle, or release any past, present and future infringements, dilutions and violations thereof.

2. Assistance. Upon request of Assignee, Assignor shall execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection with all files and records reasonably necessary to perfect the rights, title and interest in Assignee, its successors, assigns and legal representatives in the Trademarks.

3. Governing Laws. This Assignment, the rights and obligations of the parties under this Assignment, and any claim or controversy directly or indirectly based upon, arising out of or related to, this Assignment or the transactions contemplated by this Assignment (whether based upon contract, tort or any other theory), including all matters of construction, validity and performance, shall be governed by and construed in accordance with the laws of the State of Delaware, without regard to the principles of conflicts of law that would provide for the application of another law.

4. Binding. This Assignment shall be binding upon and inure to the benefit of the parties and their respective successors and permitted assigns.



5. Counterparts. This Assignment may be executed in two or more counterparts, each of which shall be deemed an original and all of which, when taken together, will be deemed to constitute one and the same agreement. In the event that any signature to this Assignment is delivered by facsimile transmission or by e-mail delivery of a portable document format (.pdf or similar format) data file, such signature shall create a valid and binding obligation of the party executing (or on whose behalf such signature is executed) with the same force and effect as if such facsimile or “.pdf” signature page were an original thereof.



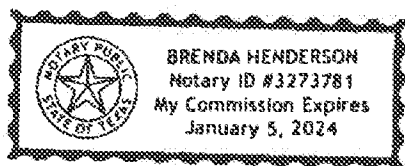

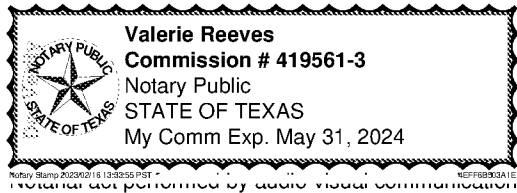
