**INTO A FOREIGN LIMITED LIABILITY COMPANY**

November 22, 2021

Pursuant to Section 10A-2A-9.13(a)(1) of the Alabama Business Corporation Law, as amended:

**First:** The name of the converting entity is Ram Tool & Supply Co., Inc., which is an Alabama corporation (the "Corporation"). The mailing address of the Corporation's principal office is: 4500 5<sup>th</sup> Avenue South, Building A, Birmingham, AL 35222. The Alabama Secretary of State entity identification number of the Corporation is 098-353.

**Second:** The certificate of incorporation of the Corporation was filed on June 5, 1984 with the office of the Judge of Probate of Jefferson County, Alabama. The certificate of incorporation of the Corporation was amended and restated on November 29, 2005 by filing of the amended and restated certificate of incorporation (the "Certificate of Incorporation") with the Office of the Secretary of State of Alabama in accordance with applicable law in effect on such date.

**Third:** The Corporation is being converted to a Delaware limited liability company.

**Fourth:** The name of the converted organization will be Ram Tool & Supply Co., LLC, a Delaware limited liability company (the "Company"), which will be registered as an authorized foreign entity in the State of Alabama under the same entity ID number as the Corporation. The street and mailing address of the principal office of the Company is: 4500 5<sup>th</sup> Avenue South, Building A, Birmingham, AL 35222.

**Fifth:** The conversion shall become effective as of the date of filing of this Statement of Conversion with the Alabama Secretary of State and the filing of a Certificate of Conversion and Certificate of Formation of the Company with the Delaware Secretary of State.

**Sixth:** The Corporation's plan of conversion (the "Plan of Conversion") was approved through a Joint Written Consent of the Board of Directors and Sole Shareholder of Ram Tool & Supply Co., Inc., dated as of the date hereof. This approval is in compliance with Sections 10-2A-7.04, 10-2A-8.01 and 10-2A-8.21 of the Alabama business Corporation Act, as amended.

**Seventh:** The conversion was approved as required by Section 18-214 of the Delaware Limited Liability Company Act.

**Eighth:** A copy of the Plan of Conversion will be furnished by the Company on request and without cost, to any owner of the Corporation or the Company.

**Ninth:** The name of the Company's registered agent for service of process in Alabama is Jeffrey DeArman. The street and mailing address of an office for the purposes of Section 10A-2A-9.15(b) is 4500 5<sup>th</sup> Avenue South, Building A, Birmingham, AL 35222.

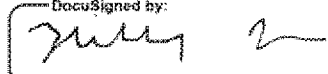
