**RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Release of Security Interest in Trademarks (“Trademark Release”) is made as of July 31, 2023, by **DEUTSCHE BANK AG NEW YORK BRANCH**, a German banking corporation (the “Collateral Agent”) in favor of **ALLPOINTS OILFIELD SERVICES LLC**, a Texas limited liability company with an address at 19450 State Highway 249, Suite 500, Houston, Texas 77070 (the “Grantor”).

WITNESSETH:

WHEREAS, the Grantor entered into a certain trademark security agreement dated June 8, 2017 with Collateral Agent, notice of which was recorded on June 9, 2017 at the United States Patent and Trademark Office (the “USPTO”) at Reel 6081, Frame 0450 (the “Trademark Security Agreement”).

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest in favor of the Collateral Agent, in and to its Trademark Collateral, including the trademarks listed in Schedule 1.


WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in the Trademark Collateral, including the trademarks listed in Schedule 1 as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the security interest, hereby terminates the Trademark Security Agreement and releases, terminates and discharges (in each case, without any recourse to, or any representation or warranty by, the Collateral Agent) any and all of its security interest in the Trademark Collateral, including the trademarks listed in Schedule 1 hereto, and assigns, transfers and conveys to the Grantor (in each case, without any recourse to, or any representation or warranty by, the Collateral Agent) any interest in the Trademark Collateral.
