**CONFIRMATORY DEED OF ASSIGNMENT**

THIS CONFIRMATORY DEED OF ASSIGNMENT ("Deed") is made on this 30<sup>th</sup> November 2020, between the following parties:

- (1) **EMERY OLEOCHEMICALS (M) SDN BHD** (Company No. 198001009328) of Lot 4, Jalan Perak, Kawasan Perindustrian Batu 9, Jalan Klang-Banting, 42500 Telok Panglima Garang, Kuala Langat, Selangor, Malaysia (the "Assignor"), which expression shall, include its successor-in interest and assigns of the one part; and
- (2) **EMERY OLEOCHEMICALS LLC** a company incorporated under the laws of the United States of America of 4900 Este Avenue, Cincinnati, Ohio 45232, United States of America ("the Assignee"), which expression shall, include its successor-in interest and assigns of the other part.

**RECITALS**


- A. The Assignor is the registered proprietor of the trademark set out in Appendix A ("the Trademark")

The said Trademark together with the associated goodwill has been sold and assigned by the Assignor to the Assignee by virtue of a Trademark Assignment Agreement dated 30<sup>th</sup> November 2020 (the "Assignment Agreement"). This Confirmatory Deed of assignment is executed for the purpose of recording the said assignment.

**NOW IT IS AGREED BY AND BETWEEN THE PARTIES AND THIS DEED WITNESSETH AS FOLLOWS:**

1. IT IS HEREBY CONFIRMED THAT the Assignor assigns, transfers, conveys, delivers to the Assignee effective as of 30<sup>th</sup> November 2020 (the "Effective Date") for US\$ 10.00 (US Dollars TEN) and other good and valuable consideration, the receipt and sufficiency of which has been duly acknowledged by the Assignor, all of the Assignor's rights, title and interest in respect of the Trademark together with the associated goodwill in respect of the goods, the entitlement to sue for past infringements and all other accrued causes of action, free from all encumbrances.
2. The Assignee hereby accepts such assignment and agrees to assume, from and after the Effective Date, all the Assignor's rights, duties, and obligations in, to and under the said Trademark. Upon such assignment, the Assignor shall be released from all rights, duties, and obligations with respect to the said Trademark.
3. The Assignee shall take the necessary steps for entering its name as registered proprietor of the said Trademark. The Assignor shall render all necessary assistance to the Assignee for the said purpose including executing all such documents and do all such things as may be necessary for vesting full rights, title and interest in the said Trademark in favor of the Assignee.


