TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of August 11, 2023 (this "Release"), is made by TRUIST BANK, a North Carolina banking corporation (as successor to SunTrust Bank), as Lender ("Lender") in favor of COLOUR REPUBLIC, LLC, a Florida limited liability company ("Grantor").

WHEREAS, pursuant to that certain Revolving Credit Agreement dated as of August 30, 2018 (as amended, modified, extended, renewed or replaced from time to time, the "Credit Agreement") by and among Grantor, Lender, and other parties thereto, Grantor granted to Lender, for the benefit of Lender, a continuing security interest in, and a right to set off against, any and all right, title and interest of Grantor in and to all Trademarks, together with, among other things, the goodwill of the business symbolized by the Trademarks, including the trademark registrations and trademark applications listed on Schedule A attached hereto (collectively, the "Trademark Collateral"); and

WHEREAS, pursuant to the Credit Agreement, Lender's security interest in the Trademark Collateral was recorded with the United States Patent and Trademark Office ("USPTO") on August 31, 2018 at Reel 6427 Frame 0653.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender, and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Credit Agreement.

SECTION 2. Termination and Release. Lender, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in, and the right to set off against, any and all right, title and interest of Grantor in and to the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Credit Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Grantor's expense.


SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of Florida.
