TERMINATION OF SECURITY INTEREST IN PATENTS AND TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN PATENTNS AND TRADEMARKS**, dated as of August 10, 2023, is made by **M&T BANK**, a New York banking corporation with its banking offices at One M&T Plaza, Buffalo, New York 14203, Attention: Office of the General Counsel (the "Bank") under the IP Security Agreement (as defined below). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the IP Security Agreement.

WHEREAS, pursuant to that certain IP Security Agreement dated as of June 22, 2022 made by **STADIUM HOLDING, INC.**, a Kansas corporation with offices at 17 Leominster Road, P.O. Box 1356, Shirley, MA 01464, and the other signatories party thereto (collectively, the "Obligor") in favor of the Lender (as amended, restated, supplemented or modified and in effect from time to time, the "IP Security Agreement"), the Obligor granted a security interest in all of Obligor's right, title and interest in, to and under its owned or thereafter acquired Patents and Trademarks, including those set forth on the attached Schedule A, and all of the goodwill of the business associated with the Patents and Trademarks (the "IP Collateral");

WHEREAS, the security interest granted to the Lender was recorded at the United States Patent and Trademark Office on June 23, 2022 at Reel 60284 and Frame 794 and at Reel 7760 and Frame 253; and


WHEREAS, the Obligor has requested, and the Lender has agreed, to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the IP Collateral affecting only such Patents and Trademarks as pledged by Obligor to the Lender (the "Released Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Lender does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the IP Security Agreement and in the Released Collateral, (b) release its security interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in the Released Collateral, and all of the goodwill of the business associated with the Released Collateral, and (d) assign, transfer and convey to Obligor any interest in such intellectual property, including the security interest. It is hereby intended that the IP Security Agreement shall remain in full force and effect with respect to all Patents and Trademarks pledged to Lender by those parties who were parties to such agreement other than the Obligor.
