Assignee shall have the sole right to sue and collect damages and/or profits for both past and present infringements of the Marks.

2. Assignee, at its own cost and expense, shall record a fully executed copy of this Assignment with the United States Patent and Trademark Office, the Canadian Intellectual Property Office, and any other agency having jurisdiction over the ownership of the Marks, including all foreign trademark offices.

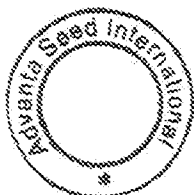
