CONFIRMATORY ASSIGNMENT



WHEREAS, the Assignor is the record owner of the trademark registrations of the marks set forth in the attached Schedule A (the “Marks”); and


WHEREAS, the Assignor and the Assignee desire to ratify and confirm the assignment and transfer of the Marks to the Assignee effective December 14, 2021;
