## INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (“IP Assignment Agreement”), is made and entered into as of May 23, 2023 (the “Effective Date”), by and between TIRESHIPED2YOU.COM LLC, a Michigan limited liability company with an address of 160 West Fort Street, Fifth Floor Detroit, Michigan, 48226 (“Assignor”), and Turbo Wholesale Holdings, LLC, a Delaware limited liability company with an address of 5793 Martin Road, Irwindale, California, 91706 (“Assignee” and together with Assignor, the “Parties” and each, individually, a “Party”).

WHEREAS, Assignor desires to assign to Assignee certain intellectual property, and Assignee desires to acquire from Assignor certain intellectual property;

NOW, THEREFORE, in consideration of the mutual covenants and agreements hereinafter set forth and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Assignment. Assignor hereby irrevocably conveys, assigns, transfers and delivers to Assignee and its successors and assigns its entire right, title and interest in and to the intellectual property set forth on Schedule A, together with any and all goodwill connected with and symbolized by the foregoing (collectively, the “Intellectual Property”), as well as the underlying business that is ongoing and existing symbolized by the Intellectual Property, and all common law rights to the Intellectual Property, the same to be held and enjoyed by Assignee for its own use and enjoyment and the use and enjoyment of its successors, assigns and other legal representatives as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment had not been made, as assignee of its respective entire right, title and interest therein, including all rights in and to all income, royalties, damages and payments hereafter due or payable with respect thereto, all causes of action (whether in law or in equity) with respect thereto, and the right to sue, counterclaim, and recover for past, present and future infringement of the rights assigned or to be assigned under this IP Assignment Agreement.
2. Filing and Recordation. The Parties hereto agree that Assignee shall promptly file and record this IP Assignment Agreement, or the equivalent of this IP Assignment Agreement to the extent required, with the appropriate Governmental Authority as necessary to record Assignee as the assignee and owner of the Intellectual Property. Assignor and Assignee authorize and request that the United States Patent and Trademark Office, and the corresponding entities or agencies in any applicable foreign jurisdictions, record Assignee as the assignee and owner of the Intellectual Property and register the registrations, from any pending applications included in the Intellectual Property to Assignee upon issuance or registration.
3. Assistance. From time to time hereafter, and without further consideration, Assignor shall execute and deliver, or shall cause to be executed and delivered, such further instruments of conveyance and transfer as Assignee may reasonably request to effect, consummate, confirm or evidence the transfer to Assignee, its successors and assigns of all of its Intellectual Property in accordance with the foregoing and as may be reasonably necessary to carry out of the intentions and purposes of this IP Assignment Agreement. If Assignee or its successor or assignee is unable, after reasonable effort, to obtain a signature of Assignor on a document reasonably necessary to perfect the transfer or assignment of the Intellectual Property, Assignor hereby irrevocably designates and appoints Assignee and its duly authorized officers and agents, as Assignor’s agents and attorneys-in-fact to act for and on Assignor’s behalf and

instead of Assignor, to execute and file any such document and to do all other lawfully permitted acts to further the purposes of this IP Assignment Agreement with the same legal force and effect as if executed by Assignor. Each Party shall pay its own costs incurred to comply with its obligations hereunder.


4. Successors. This IP Assignment Agreement shall inure to the benefit of and is binding upon the respective successors and assigns of Assignor and Assignee.
5. Counterparts. This IP Assignment Agreement may be executed in one or more counterparts (including by means of DocuSign (or similar) or transmission in portable document format (.pdf)), all of which shall be considered one and the same instrument and shall become effective when one or more counterparts have been signed by each of the Parties and delivered to the other Parties; it being understood that all Parties need not sign the same counterpart.


