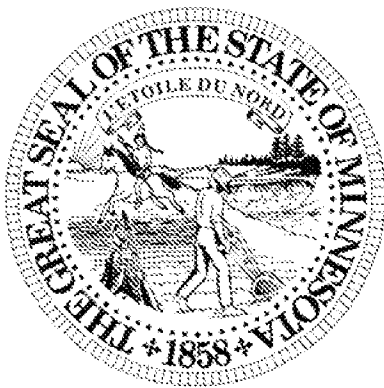

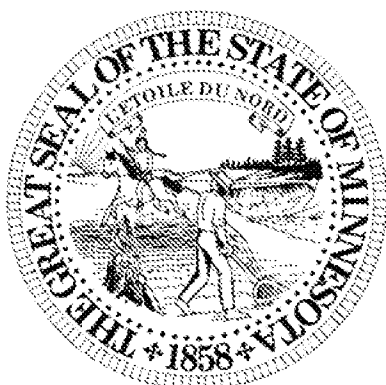

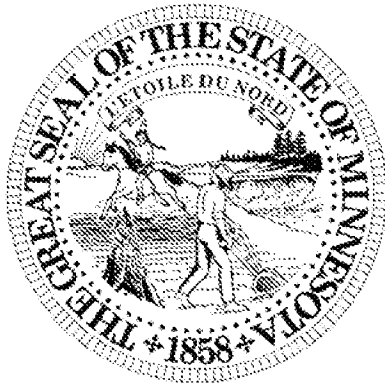

These Articles of Conversion relate to the conversion of WSB & Associates, Inc., a Minnesota corporation organized under Chapter 302A of the Minnesota Statutes, into WSB LLC, a Minnesota limited liability company organized under the Chapter 322C of the Minnesota Statutes, as is required by Sections 302A.686 and 322C.1009 of the Minnesota Statutes:

1. Attached hereto as Exhibit A is a copy of the Plan of Conversion of WSB & Associates, Inc. into WSB LLC (the "Plan").
2. The name of the converting organization is WSB & Associates, Inc., a Minnesota corporation (the "Converting Organization"), and the name to which the Converting Organization is to be changed is WSB LLC, a Minnesota limited liability company (the "Converted Organization").
3. The Converted Organization will be a limited liability company governed under Chapter 322C of the Minnesota Statutes.
4. The conversion contemplated by these Articles of Conversion will be effective upon the filing of these Articles of Conversion with Secretary of State of the State of Minnesota.
5. The Plan was approved in a manner that complied with the Converting Organization's governing statute and as required by Chapter 302A and Chapter 322C of the Minnesota Statutes.
6. Attached hereto as Exhibit B is a copy of the Articles of Organization of the Converted Organization.

**PLAN OF CONVERSION
FOR THE CONVERSION

This PLAN OF CONVERSION (this "Plan"), pursuant to Sections 302A.682 and 322C.1007 of the Minnesota Statutes, sets forth and accounts for the conversion WSB & Associates, Inc., a Minnesota corporation, into WSB LLC, a yet to be formed Minnesota limited liability company.

1. Name of Converting Organization. The name of the converting organization is WSB & Associates, Inc., a Minnesota corporation formed under Chapter 302A of the Minnesota Statutes (the "Converting Organization").
2. Name of Converted Organization. The name of the converted organization is WSB LLC (the "Converted Organization").
3. Form of Converted Organization. The Converted Organization will be a limited liability company governed under Chapter 322C of the Minnesota Statutes.
4. Terms and Conditions of Proposed Conversion. The terms and conditions of the proposed conversion are as follows:
 - a. Effective Date of Conversion. The Conversion will become effective when the Articles of Conversion to which this Plan is attached are filed with the Secretary of State of the State of Minnesota (such date being the "Effective Date").
 - b. Governing Laws; Articles of Organization. The Articles of Organization of WSB LLC, attached to these Articles of Conversion as Exhibit B and incorporated by reference herein, will be the Articles of Organization of the Converted Organization as of the Effective Date and will supersede the Articles of Incorporation of the Converting Organization.
5. Management; Bylaws; Officers. At the Effective Date:
 - a. Bylaws. The Bylaws of the Converting Organization will be cancelled.
 - b. Operating Agreement. The sole member of the Converted Organization will adopt an operating agreement (as that term is defined in Chapter 322C of the Minnesota Statutes).
 - c. Officers. The officers of the Converting Organization holding office immediately before the Effective Date shall be the initial officers of the Converted Organization from and after the Effective Date and will hold such officer positions until their successors are duly elected and qualified.
6. Conversion of Shares into Membership Interests. At the Effective Date, each issued and outstanding share of common stock, no par value, of the Converting Organization will be converted into one unit of membership interest in the Converted Organization. No shares of the

Converting Organization's common stock issued and outstanding at the Effective Date will remain as a result of the Conversion.
