RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of August 30, 2023 (the "Effective Date"), is made by DEUTSCHE BANK AG NEW YORK BRANCH, in its capacity as Collateral Agent (in such capacity, the "Collateral Agent"), in favor of DMT SOLUTIONS GLOBAL CORPORATION, a Delaware corporation ("DMT"), and BCC SOFTWARE, LLC, a Delaware limited liability company ("BCC" and, together with DMT, the "Grantors").

WHEREAS, pursuant to that certain Term Loan Security Agreement, dated as of July 2, 2018, by and among the Collateral Agent, the Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the "Security Agreement"), the Grantors granted to the Collateral Agent, in its capacity as Collateral Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, the Grantors executed and delivered a Term Loan Trademark Security Agreement, dated as of April 30, 2021 (the "Trademark Security Agreement"), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 3, 2021 at Reel/Frame 7277/0760;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreement, as applicable.

2. Release. The Collateral Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its collateral pledge, grant, assignment, lien, and security interest in and to the following Collateral arising under the Security Agreement and the Trademark Security Agreement:

- a. Marks listed on Schedule I attached hereto (in no event shall Collateral include any application for registration of a trademark filed with the United States Patent and Trademark Office ("PTO") on an intent-to-use basis until such time (if any) as a statement of use or amendment to allege use is accepted by the PTO);
- b. All goodwill associated with such Marks; and
- c. All proceeds of any and all of the foregoing.

If and to the extent that the Collateral Agent has acquired any right, title or interest in and to the Collateral under the Trademark Security Agreement, the Collateral Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantors.

3. Termination. The Collateral Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreement.

4. Further Assurances. The Collateral Agent agrees to take all further actions, and provide to each Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by such Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.
