SUPPLEMENT NO. 1 TO INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Supplement No. 1 to Intellectual Property Security Agreement (this “*Supplement No. 1*”) is made as of the 11th day of September, 2023, by **VEGAMOUR, INC.**, a Delaware corporation (the “*Grantor*”), in favor of **JPMORGAN CHASE BANK, N.A.** (“*Lender*”).

WHEREAS, the Grantor executed and delivered an Intellectual Property Security Agreement dated as of March 16, 2022 (as amended and of record from time to time hereinafter, the “*Agreement*”) in favor of the Lender, pursuant to which the Grantor granted a security interest in certain Copyrights, Trademarks, and Patents (collectively, the “*Intellectual Property Collateral*”). Capitalized terms not otherwise defined herein shall have the meaning set forth in the Agreement;

WHEREAS, the Agreement was recorded on March 16, 2022 at Reel 007661, Frame 0560 in the Trademark division of the U.S. Patent and Trademark Office;

WHEREAS the Grantor desires to confirm the grant of a security interest in certain additional Intellectual Property Collateral in favor of the Lender.

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:

1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Agreement.
2. Supplement to Trademark Exhibit C. Trademark Exhibit C to the Agreement is hereby supplemented, but not replaced, by Trademark Exhibit C-1 annexed hereto.
3. Miscellaneous:
 - a. Except as provided herein, all terms and conditions of the Agreement remain in full force and effect.
 - b. This Supplement covers the entire understanding of the parties with respect to the matters set forth herein and supersedes all prior discussions and negotiations hereon.
