**NOTWITHSTANDING ANYTHING HEREIN TO THE CONTRARY, THE LIEN AND SECURITY INTEREST GRANTED TO THE COLLATERAL AGENT PURSUANT TO OR IN CONNECTION WITH THIS SHORT-FORM TRADEMARKS SECURITY AGREEMENT, THE TERMS OF THIS SHORT-FORM TRADEMARKS SECURITY AGREEMENT, AND THE EXERCISE OF ANY RIGHT OR REMEDY BY THE COLLATERAL AGENT OR REQUISITE LENDERS HEREUNDER ARE SUBJECT TO THE PROVISIONS OF THE INTERCREDITOR AGREEMENT, DATED AS OF THE DATE HEREOF (AS AMENDED, RESTATED, AMENDED AND RESTATED, SUPPLEMENTED OR OTHERWISE MODIFIED FROM TIME TO TIME, THE “INTERCREDITOR AGREEMENT”), AMONG HPS INVESTMENT PARTNERS, LLC, AS THE INITIAL FIRST LIEN COLLATERAL AGENT, WILMINGTON TRUST, NATIONAL ASSOCIATION, AS THE INITIAL SECOND LIEN REPRESENTATIVE, AND ACKNOWLEDGED AND AGREED BY THE CREDIT PARTIES. IN THE EVENT OF ANY CONFLICT BETWEEN THE TERMS OF THE INTERCREDITOR AGREEMENT AND THIS SHORT-FORM TRADEMARKS SECURITY AGREEMENT, THE TERMS OF THE INTERCREDITOR AGREEMENT SHALL CONTROL.**

SHORT-FORM TRADEMARKS SECURITY AGREEMENT

September 20, 2023

WHEREAS, each of INDEPENDENT STUDIO SERVICES, INC., a California corporation, MBS SERVICES HOLDINGS, LLC, a Delaware limited liability company, and STUDIO GRAPHICS LLC, a California limited liability company (collectively, the “Grantors”, and each, a “Grantor”), has adopted, used, is using, or intends to use, and is the owner of the trademarks and trademark applications listed in the attached Schedule of Registered Trademarks, and the registrations and applications associated therewith;

WHEREAS, each Grantor has contemporaneously with the execution of this Short-Form Trademarks Security Agreement entered into the Second Lien Pledge and Security Agreement dated as of September 20, 2023 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), in which each Grantor has granted certain interests in favor of Wilmington Trust, National Association, as Collateral Agent for the benefit of the Secured Parties (as defined therein) (“Collateral Agent”); and

WHEREAS, pursuant to the Security Agreement, each Grantor has agreed with Collateral Agent and the Secured Parties to execute this Short-Form Trademarks Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor hereby grants to Collateral Agent for the benefit of the Secured Parties, to the extent provided in the Security Agreement (the terms and conditions of which are hereby incorporated herein), a security interest in all of its right, title and interest in, to and under all the trademarks, whether now owned or at any time hereafter acquired, of such Grantor that are registered with, or for which applications for registration have been filed with, the United States Patent and Trademark Office pursuant to 15 U.S.C. § 1051(a), including the trademarks listed on the attached Schedule of Registered Trademarks, and all registrations and pending applications associated therewith (excluding any application for registration of a trademark filed on an intent-to-use basis pursuant to 15 U.S.C. § 1051(b) solely to the extent that the grant of a security interest in any such trademark application would materially adversely affect the validity or enforceability of the resulting trademark registration or result in cancellation of such trademark application or any resulting trademark registration), as collateral security for the prompt and complete payment and performance when due of all the Secured Obligations (as defined in the Security


Agreement). Notwithstanding the foregoing, in the event of any conflict between this Short-Form Trademarks Security Agreement and the Security Agreement, the Security Agreement shall control.

Notwithstanding anything herein to the contrary, the lien and security interest granted to Collateral Agent hereunder pursuant to or in connection with this Short-Form Trademarks Security Agreement, the terms of this Short-Form Trademarks Security Agreement, and the exercise of any rights or remedy by the Collateral Agent hereunder are subject to the provisions of the Intercreditor Agreement. In the event of any conflict between the terms of the Intercreditor Agreement and this Short-Form Trademarks Security Agreement, the terms of the Intercreditor Agreement shall control.


