## **ACKNOWLEDGMENT OF TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This Acknowledgment of Termination and Release of Intellectual Property Security Agreement (“Release”), dated as of September 20, 2023, is made with reference to the Patent Security Agreement dated May 20, 2022 between Signal Hound, LLC, a Washington limited liability company (the “Company”) and CP BF Lending, LLC, a Delaware limited liability company (the “Lender”) (as further amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Patent Agreement”) and the Trademark Security Agreement dated May 20, 2022 between the Company and the Lender (as further amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Trademark Agreement” and together with the Patent Agreement, the “IP Agreements”), which were executed pursuant to the Loan and Security Agreement by and between Lender, Company, and Signal Hound Holdings, LLC, a Delaware limited liability company, dated May 20, 2022 (as amended, restated, amended and restated, supplemented or otherwise modified, the “Loan Agreement”).

**WHEREBY**, pursuant to the terms of the Loan Agreement, Company granted to Lender a security interest in all of Company’s right, title and interest in, to and under all of the Collateral (as defined in the Loan Agreement), including without limitation, all of the Company’s Intellectual Property (as defined in the Loan Agreement).

**WHEREBY**, the Patent Agreement was recorded in the United States Patent and Trademark Office (“USPTO”) on May 25, 2022, Reel 060015 at Frame 0402, with respect to the patents set forth on Exhibit A hereto (the “Patents”).

**WHEREBY**, the Trademark Agreement was recorded in the United States Patent and Trademark Office on May 25, 2022, Reel 7733 at Frame 0267, with respect to the trademarks set forth on Exhibit B hereto (the “Trademarks”).

**NOW, THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Lender and Company agree as follows:

**SECTION 1.** Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Loan Agreement or IP Agreements.

**SECTION 2.** Termination and Release. Lender, without representation, warranty, or recourse (except as set forth herein), hereby:

- (a) terminates, cancels, discharges, and releases the security interest in Company’s right, title, and interest in, to and under its Intellectual Property granted pursuant to the IP Agreements and the Loan Agreement, including, without limitation, those Patents listed on Exhibit A hereto, and those Trademarks on Exhibit B hereto, and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties

and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof (collectively, "Intellectual Property Collateral"); and

(b) authorizes the recordation of this Release with the USPTO at Company's expense.

Notwithstanding anything to the contrary herein, Lender represents and warrants that it has not assigned, transferred, restricted, or otherwise encumbered any security interest it has against the Intellectual Property Collateral.


