**RELEASE OF TRADEMARK SECURITY AGREEMENT**

This Release of Trademark Security Agreement (this “Release”) is made as of September 29, 2023, by WEBSTER BANK, N.A., in its capacity as administrative agent (the “Agent”) for the benefit of TWIN BORO MANAGEMENT, LLC, a Delaware limited liability company (the “Grantor”). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Trademark Security Agreement referred to below (whether directly therein or by reference to another agreement).

**W I T N E S S E T H:**

WHEREAS, the Grantor and the Agent are parties to that certain (i) Guaranty and Security Agreement dated as of February 18, 2022 (as amended, restated, supplemented or otherwise modified through the date hereof, the “Security Agreement”), among the Grantor, each other grantor from time to time party thereto, and the Agent, and (ii) Trademark Security Agreement, dated as of February 18, 2022 (the “Trademark Security Agreement”), pursuant to which the Grantor mortgaged, pledged, hypothecated and granted to the Agent for the benefit of the Secured Parties a Lien on and security interest in (the “Security Interest”) all of the right, title and interest of the Grantor in, to and under the Trademark Collateral, including the Trademarks set forth on Schedule I hereto;

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on March 1, 2022 at Reel 007645 and Frame 0607; and

WHEREAS, Grantor has requested that the Agent release, and the Agent is willing to release Security Interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent (i) hereby terminates, releases and discharges the Security Interest in the Trademark Collateral, and (ii) assigns, transfers and conveys any and all right, title or interest of the Agent in the Trademark Collateral to the Grantor. The Grantor, and any successor to the Grantor (including any person or entity hereafter holding any right, title or interest in the Trademark Collateral) is hereby authorized to record this release with the United States Patent and Trademark Office.

This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York.
