**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of September 29, 2023, is made by JPMORGAN CHASE BANK, N.A., in its capacity as Agent for the Lenders (in such capacity, the “Agent”) in favor of AMERIPRIDE SERVICES, LLC (formerly known as AmeriPride Services Inc.), a Delaware limited liability company (the “Released Pledgor”). Capitalized terms not defined herein shall have the meaning ascribed to them, directly or by reference, in the Trademark Security Agreement (as defined below).

WHEREAS, the Released Pledgor, together with the other Pledgors party thereto, executed and delivered that certain U.S. Pledge and Security Agreement, dated as of March 28, 2017, in favor of the Agent (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), pursuant to which the Released Pledgor executed and delivered that certain Trademark Security Agreement, dated as of March 19, 2018 in favor of the Agent (the “Trademark Security Agreement”), which was recorded in the United States Patent and Trademark Office on March 21, 2018 at Reel/Frame 6296/0726;

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, the Released Pledgor pledged and granted to the Agent for the benefit of the Secured Parties a lien on and security interest in and to (the “Security Interest”) all of its right, title and interest in, to and under all Trademarks of the Released Pledgor, including those listed on Schedule A attached hereto, other than intent-to-use trademark applications to the extent set forth therein (collectively, the “Released Trademark Collateral”); and

WHEREAS, the Released Pledgor has requested and the Agent has agreed to now terminate and release its Security Interest in the Released Trademark Collateral.

NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration the receipt and adequacy of which are hereby acknowledged, the Agent hereby (i) terminates, cancels, discharges and releases all of its Security Interest in the Released Trademark Collateral which had been granted to it by the Released Pledgor pursuant to the Security Agreement and the Trademark Security Agreement, and (ii) re-assigns, re-transfers and re-conveys to the Released Pledgor any right, title or interest the Agent may have in the Released Trademark Collateral of such Released Grantor, in each case without recourse to the Agent, and without representation or warranty of any kind, and any right, title or interest of the Agent in the Released Trademark Collateral shall hereby cease and become void. The Agent hereby terminates and cancels the Trademark Security Agreement.

The Released Pledgor (and any successor to such Released Pledgor, including any person or entity hereafter holding any right, title or interest in and to the Released Trademark Collateral of such Released Pledgor) is hereby authorized to record this Release with the United States Patent and Trademark Office, at the Released Pledgor’s sole cost and expense.


The Agent hereby agrees to execute, at the Released Pledgor's sole cost and expense, such other documents reasonably satisfactory to the Agent as the Released Pledgor may reasonably request to effectuate the termination of the Security Interest in the Released Trademark Collateral.

THIS AGREEMENT SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.
