**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of September 29, 2023 (this "Release"), is made by KENNEDY LEWIS MANAGEMENT LP., a Delaware limited partnership, in its capacity as collateral agent for the Lenders (together with its successors and assigns, "Agent") in favor of WEST AFFUM HOLDINGS CORP., an exempted company incorporated with limited liability in the Cayman Islands (the "Grantor").

**WITNESSETH**

WHEREAS, Grantor entered into a Loan and Security Agreement with certain financial institutions party thereto (the "Lenders") and Agent, in its capacity as collateral agent for itself and the Lenders, dated as of September 24, 2020 (as amended, restated, or otherwise modified from time to time, the "Loan Agreement");

WHEREAS, pursuant to the Loan Agreement, Grantor executed the Intellectual Property Security Agreement, dated as of September 24, 2020 (the "Agreement") and recorded with the U.S. Patent and Trademark Office (the "USPTO") on September 25, 2020 at Reel/Frame No. 7061/0533 and on September 28, 2020 at Reel/Frame No. 53910/0783, pursuant to which Grantor granted and pledged to Agent for its benefit and the benefit of the Lenders a security interest in all of Grantor's right, title and interest in, to and under the Intellectual Property Collateral (as defined in the Agreement).

WHEREAS, Grantor has requested that Agent release its security interest in and to all of its right, title and interest in, to and under the Intellectual Property Collateral.


