**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL, dated as of October 16, 2023 (this “Release”), is made by NXT Capital, LLC, as administrative agent (“Administrative Agent”), in favor of Coopercraft Communications, Inc., a Georgia corporation (“Coopercraft”), Knight Security Systems, LLC, a Texas limited liability company (“Knight Security”), and Communications Electronics, Inc., a Maryland corporation (“Communications Electronics” and, collectively with Coopercraft and Knight Security, the “Grantors”), as follows:

**WITNESSETH:**

WHEREAS, pursuant to that certain Security Agreement, dated as of March 4, 2019 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), by and among the Grantors and the other parties from time to time party thereto in favor of Administrative Agent, and that certain agreements described on Annex I attached hereto (the “Trademark Security Agreements”), the Grantors granted a security interest in certain collateral in favor of Administrative Agent, including the IP Collateral (as hereinafter defined); and

WHEREAS, Administrative Agent now desires to terminate and release the Trademark Security Agreements and the entirety of its security interest in the IP Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, Administrative Agent hereby agrees as follows:

1. **Definitions.** The term “IP Collateral”, as used herein, shall have the meaning set forth in the Trademark Security Agreements, and shall also include all of each Grantor’s right, title or interest in, or to any and all of the Trademarks listed on Annex I attached hereto. Capitalized terms not defined herein have the meanings set forth in the Security Agreement or the Trademark Security Agreements, as applicable.

2. **Release of Security Interest.** Administrative Agent, without recourse, representation or warranty and at the Grantors’ sole cost and expense, hereby terminates, cancels, releases, relinquishes and discharges, in its entirety, for the benefit of the Grantors, and their successors and assigns, their security interest in and to the IP Collateral, the Trademark Security Agreements and any and all right, title and interest of Collateral Agent in, to and under the IP Collateral shall hereby be terminated, cancelled, released, relinquished and discharged. Administrative Agent hereby authorizes the Grantors and their successors, assigns or other legal representatives to file this Release with the United States Patent and Trademark Office, at the sole expense of the Grantors, to evidence and effectuate the release and termination of Administrative Agent’s security interest in the IP Collateral.

3. **Delivery by Facsimile.** Delivery of an executed signature page to this Release by facsimile or electronic (including .pdf file) transmission shall be as effective as delivery of a manually signed counterpart of this Release. Electronic signatures will have the same force and effect as manual signatures.

4. **Governing Law.** THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HERETO SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
