**TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of October 16, 2023, by MONROE CAPITAL MANAGEMENT ADVISORS, LLC, in its capacity as administrative for itself, the Lenders, and certain Affiliates of the Lenders (in such capacity, “Administrative Agent”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, S&S Healthcare Strategies, Ltd., an Ohio limited liability company (the “Grantor”) and Administrative Agent were parties to that certain Trademark Security Agreement dated as of August 2, 2018 (the “Security Agreement”) pursuant to which Grantor granted to Administrative Agent a security interest in, all of its right, title and interest in, to and under the Trademark Collateral as collateral security for certain obligations owing by Grantor to Administrative Agent, including the Trademarks set forth on Schedule 1 hereto;

WHEREAS, the Security Agreement was recorded by the United States Patent and Trademark Office on August 2, 2018 at Reel 6401, Frame 0981;

WHEREAS, Grantor has requested that Administrative Agent release its Lien on and security interest in the Trademark Collateral and reassign any and all rights in the same to Grantor;

WHEREAS, Grantor has satisfied and fulfilled all of its obligations to release the Administrative Agent’s Lien on and security interest in the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:



Administrative Agent hereby releases and terminates its Lien on and security interest in all of Grantor’s right, title and interest in, to and under all of Grantor’s Trademark Collateral (as defined in the Security Agreement), including, without limitation, the Trademarks listed on Schedule 1 attached hereto and all products and Proceeds of the foregoing.

2. Administrative Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Administrative Agent, any and all of Administrative Agent’s right, title and interest in, to and under the Trademark Collateral and hereby terminates the Security Agreement.
