# TRADEMARK ASSIGNMENT AGREEMENT

## Eco-Advantage

This TRADEMARK ASSIGNMENT AGREEMENT ("**Assignment**"), dated as of October 18, 2023, is made by American Electric Power Company, Inc., a New York corporation, with its principal place of business at 1 Riverside Plaza, Columbus, Ohio 43215 ("**Parent**"), in favor of AEP Energy, Inc., an Illinois corporation, having its principal place of business at 1 Riverside Plaza, Columbus, Ohio ("**AEPE**").

WHEREAS, Parent wishes to transfer to AEPE, and AEPE wishes to accept from Parent all of Parent's right, title, and interest in and to the federally registered trademark *Eco-Advantage*, having Registration No. 4414658 (the "**Trademark**") and related rights, together with the goodwill of the business connected with the use of and symbolized by the Trademark, subject to the terms and conditions set forth herein.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Assignment. Parent hereby irrevocably conveys, transfers, and assigns to AEPE, and AEPE hereby accepts from Parent, all of Parent's right, title, and interest in and to the Trademark together with the goodwill of the business connected with the use of, and symbolized by, the Trademark.

2. Recordation and Further Actions. Parent hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Trademark Assignment upon request by AEPE. Following the date hereof, upon AEPE's reasonable request, and at AEPE's sole cost and expense, Parent shall take such steps and actions, and provide such cooperation and assistance to AEPE and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence, or perfect the assignment of the Trademark to AEPE, or any assignee or successor thereto.

3. Counterparts. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this Assignment delivered by e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.

4. Successors and Assigns. This Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

5. Governing Law. This Assignment and any claim, controversy, dispute, or cause of action (whether in contract, tort, or otherwise) based upon, arising out of, or relating to this

Assignment and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Ohio, without giving effect to any choice or conflict of law provision or rule whether of the State of Ohio or any other jurisdiction.

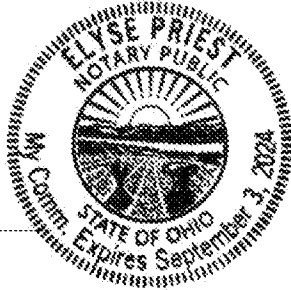
