**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Agreement") dated as of November 3, 2023, from Webster Bank, N.A., as agent (the "Agent"), in favor of Triumvirate Environmental, Inc., a Massachusetts corporation and Commonwealth Recycling Service, Inc., a Pennsylvania corporation (collectively, the "Grantors").

WITNESSETH:

WHEREAS, in connection with the Notice of Grant of Security Interests in Trademarks, dated as of March 30, 2018 (the "Notice"), the Agent was granted a continuing security interest in and continuing lien upon the trademarks and trademark applications shown on Schedule 1 to the Notice from the Grantors (all capitalized terms used herein, but not otherwise defined herein, shall have the meanings set forth or referenced in the Notice);

WHEREAS, the Notice was recorded in the Trademark Assignment Division of the United States Patent and Trademark Office (the "USPTO") on March 30, 2018 at Reel 006313, Frame 0797; and

WHEREAS, the Agent now wishes to release its liens on, and security interests in, the trademarks and trademark applications set forth on Schedule A attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Agreement, the Agent hereby states as follows:

1. Release of Security Interest. The Agent and their respective successors, indorsees, transferees and assigns, hereby terminates the Notice and terminates, irrevocably releases and fully discharges all of its security interest and lien in, to and on the trademarks and trademark applications, and reassigns, re-transfers, and re-conveys any and all right, title and interest that it may have in or to the trademarks and trademark applications to the Grantors.


2. Recordation. The Grantors or their authorized agent is authorized to record this Agreement with the USPTO.

3. Further Assurances. The Agent shall take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any documents or other instruments), reasonably requested by the Grantors, and at the Grantors' cost and expense, to more fully and effectively effectuate the release of liens and security interests contemplated hereby.
