**RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY**

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release"), dated as of February 17, 2023, is made by JPMorgan Chase Bank, N.A. ("Lender") in favor of Vindex LLC, a Delaware limited liability company ("Vindex"), Belong Gaming, LLC, a Delaware limited liability company ("Belong") and Hitbox, LLC, a Delaware limited liability company. ("Hitbox" and, together with Vindex and Belong, "Grantors").

**WITNESSETH:**

WHEREAS, Grantors have executed and delivered that certain Intellectual Property Security Agreement, dated as of February 23, 2021 ( the "Security Grant") in favor of Lender, pursuant to which Grantors granted to Lender, a security interest in and to all of its rights, title and interest in the Intellectual Property Collateral (as defined in the Security Grant) and which Security Grant was recorded with the United States Patents and Trademark Office ("USPTO") on March 23, 2021 at Reel/Frame No. 007232/0549;

WHEREAS, pursuant to that certain Payoff Letter, dated as of February 16, 2023, by Lender to, *inter alia*, Vindex (the "Payoff Letter"), Lender has released the security interest in and to the Intellectual Property Collateral, including the Copyrights, Patents and Trademarks listed on Exhibit A, Exhibit B and Exhibit C hereto, respectively (collectively, the "Released Collateral");

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Grantors and Lender agree as follows:

1. Termination and Release. Lender hereby releases, terminates, forever discharges, and cancels, without any representation or warranty, any and all liens and security interests it may have in and to the Released Collateral.
2. Recordation. Lender hereby authorizes the Grantors and its designees to record this Release with the USPTO or any other applicable governmental authority at the Grantors' expense.
3. Further Assurances. Lender, at the Grantors' expense, hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the security interest release contemplated herein.
