**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (the “Release”) is made as of November 20, 2023, by Alter Domus (US) LLC, as administrative agent (in such capacities and together with its successors and permitted assigns, the “Administrative Agent”), in favor of AFIMAC U.S. INC., an Ohio corporation (the “Grantor”). Capitalized terms used but not otherwise defined herein shall have the meanings given to the in the Trademark Security Agreement (as defined below), whether directly therein or by reference to another agreement.

**WITNESSETH**

WHEREAS, pursuant to that certain Security and Pledge Agreement, dated as of August 16, 2022 (as may have been amended, modified, extended, restated, replaced, or supplemented from time to time, the “Security Agreement”), the Grantor executed and delivered those certain Notice of Grant of Security Interest in Trademarks, dated as of August 16, 2022, (the “Trademark Security Agreement”) in favor of the Administrative Agent, which was recorded with the U.S. Patent and Trademark Office on August 17, 2022 at Reel/Frame 7800/0238 and with the Canadian Intellectual Property Office on August 16, 2022;

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, the Grantor granted to the Administrative Agent a security interest (the “Security Interest”) in all of such Grantor’s right, title and interest in, to the Intellectual Property of the Grantor identified on Annex 1 attached hereto (the “Trademark Collateral”); and

WHEREAS, the Grantor requests a release of the Trademark Collateral, and the Administrative Agent desires to terminate and grant a release of the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby (a) terminates the Trademark Security Agreement, (b) releases, relinquishes, terminates and discharges the Security Interest in the Trademark Collateral in its entirety and (c) reassigns to the Grantor any and all right, title and interest of any nature whatsoever which it may hold in or to the Trademark Collateral of the Grantor (including, without limitation, the Trademarks and Trademark Applications of the Grantor identified on Annex 1 attached hereto).

The Administrative Agent hereby (a) authorizes the Grantor and its successors, assigns or other legal representatives to file this Release with the U.S. Patent and Trademark Office and the Canadian Intellectual Property Office to evidence and effectuate the release and termination of the Administrative Agent’s security interest in the Trademark Collateral and (b) authorizes the Commissioner for Trademarks and Registrar of Trademarks, as applicable, to record and register this Release.

At the reasonable request and sole expense of the Grantor, the Administrative Agent agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions necessary to carry out the purposes of this Release.

Delivery of an executed signature page of this Release by facsimile or electronic transmission (e.g., email of a PDF file) shall be as effective as delivery of a manually executed counterpart hereof. The words “executed,” “signed,” “signature,” and words of like import in this Release shall be deemed to include electronic signatures or electronic records, each of which shall be of the same legal effect, validity or enforceability as a manually executed signature or the use of a paper-based recordkeeping system, as the case may be, to the extent and as provided for in any applicable law, including the Federal Electronic Signatures in Global and National Commerce Act, the New York State Electronic Signatures and Records Act, or any other similar state laws based on the Uniform Electronic Transactions Act.

IN WITNESS WHEREOF, the Administrative Agent has caused this Release to be duly executed and delivered by its officer thereunto duly authorized as of the date first above written.
