INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT, dated as of November 18, 2023 (this "Agreement"), is by and among Bellator Sport Worldwide LLC, a Delaware limited liability company, (the "Assignor") and PFL Acquisition Holdco, LLC, a Delaware limited liability company (the "Assignee"). Capitalized terms used herein but not otherwise defined herein shall have the meanings set forth in the Purchase Agreement (as defined below).

WHEREAS, the Assignor and the Assignee, have entered into that certain Asset Purchase Agreement, dated as of November 18, 2023 (as may be amended from time to time, the "Purchase Agreement"); and

WHEREAS, pursuant to the Purchase Agreement, the Assignor has agreed to sell, assign, transfer, convey and deliver to the Assignee all of the Assignor's right, title and interest in and to the (a) trademark registrations set forth on Exhibit A hereto (including any and all goodwill symbolized by any of the foregoing) (the "Trademarks"); (b) Internet domain name registrations set forth on Exhibit B hereto (the "Domain Names"); and (c) copyright registrations set forth on Exhibit C hereto (the "Copyrights"), and together with the Trademarks and Domain Names, collectively, the "Assigned Intellectual Property");

NOW THEREFORE, for good and valuable consideration, including the premises and covenants set forth in the Purchase Agreement, the receipt and sufficiency of which are hereby acknowledged, the parties hereto hereby agree as follows:

1. Assignment. Pursuant to, and upon the terms and subject to the conditions of, the Purchase Agreement, as of the Closing, the Assignor hereby sells, assigns, transfers and conveys to the Assignee, and the Assignee hereby purchases, acquires and accepts from the Assignor, the entire right, title and interest of the Assignor in and to the Assigned Intellectual Property (free and clear of any and all Encumbrances, other than Permitted Encumbrances, as of the Closing), including any and all royalties, fees, income, payments, and other proceeds due or payable with respect to any and all of the foregoing and any and all claims and causes of action with respect to any of the foregoing, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages, in each case, as of the Closing.

2. Due Authorization; Further Assurances. The Assignor hereby authorizes and requests the Commissioner of Trademarks of the United States, the Register of Copyrights of the United States, and any other official of any applicable Governmental Authority or Internet domain name registrar, to (a) record the Assignee as assignee of the right, title and interest in and to the Assigned Intellectual Property and (b) issue any and all registrations from any and all applications for registration included in the Assigned Intellectual Property to and in the name of the Assignee.

3. Further Action. The Assignor shall from time to time after the date hereof, at the reasonable request of the Assignee and at the Assignee's sole cost and expense, execute and deliver to the Assignee such additional instruments of conveyance in addition to this Agreement as are reasonably necessary to transfer the Assigned Intellectual Property to the Assignee. Notwithstanding anything herein to the contrary, the Assignee shall, at its sole cost and expense, be solely responsible for preparing any instruments of conveyance in addition to this Agreement and the Purchase Agreement necessary to

owner thereof, and for filing and recording all instruments of conveyance (including this Agreement) with any applicable Governmental Authority or Internet domain name registrar. As soon as reasonably practicable after the date hereof, the Assignee shall record the instruments of conveyance with the applicable Governmental Authority or Internet domain name registrar. For the avoidance of doubt, the Assignee is solely responsible for any filings or costs necessary or desirable to prosecute or maintain any Assigned Intellectual Property on or after the date hereof.

4. Miscellaneous. Sections 1.1 (Definitions), 8.4 (Modifications; Waiver; Remedies Cumulative), 8.5 (Expenses), 8.7 (Assignments, Successors and No Third-Party Rights), 8.9 (Construction), 8.10 (Severability), 8.12(b) (Waiver of Jury Trial) and 8.13 (Counterparts) of the Purchase Agreement are incorporated herein by reference and shall apply to this Agreement *mutatis mutandis*.

5. Entire Agreement. This Agreement, the Purchase Agreement and the other Transaction Documents constitute the entire agreement of the parties hereto with respect to the subject matter hereof and supersede all prior agreements and undertakings, both written and oral, between the Assignor and the Assignee with respect to the subject matter hereof.

6. Governing Law; Submission to Jurisdiction.

(a) This Agreement shall be governed by, and construed in accordance with, the laws of the State of New York without regards to any choice of law or conflict of laws principles.

(b) Each party hereto, for itself and its successors and assigns, irrevocably agrees that any Action arising out of or relating to this Agreement or any of the Contemplated Transactions shall be brought and determined exclusively in any New York federal court sitting in the Borough of Manhattan of the City of New York (or, if subject matter jurisdiction in that court is not available, exclusively in any appropriate New York state court sitting in the Borough of Manhattan of The City of New York) (and each such party shall not bring any Action arising out of or relating to this Agreement or any of the transactions contemplated hereby in any court other than the aforesaid courts), and each such party, for itself and its successors and assigns and in respect to its property, hereby irrevocably submits with regard to any such Action, generally and unconditionally, to the exclusive jurisdiction of the aforesaid courts. Each party hereto, for itself and its successors and assigns, hereby irrevocably waives, and agrees not to assert, by way of motion, as a defense, counterclaim or otherwise, in any such Action: (i) any claim that it is not personally subject to the jurisdiction of the above-named courts for any reason other than the failure to lawfully serve process; (ii) that it or its property is exempt or immune from jurisdiction of such court or from any legal process commenced in such courts (whether through service of notice, attachment prior to judgment, attachment in aid of execution of judgment, execution of judgment or otherwise); and (iii) that (A) such Action in any such court is brought in an inconvenient forum; (B) the venue of such Action is improper; and (C) this Agreement, the transactions contemplated hereby or the subject matter hereof may not be enforced in or by such courts.

7. Headings. The division of this Agreement into Sections and other Subdivisions and the insertion of headings are for convenience of reference only and shall not affect or be utilized in construing or interpreting this Agreement.

8. No Claims.

(a) This Agreement is subject in all respects to the terms and conditions of the Purchase Agreement, and nothing in this Agreement, express or implied, shall, is intended to, or shall be

construed to (i) create any additional obligations, covenants, agreements, representations or warranties, or alter, amend, modify, expand, rescind, waive, supersede or in any way affect any of the obligations, covenants, agreements, representations or warranties of the Assignor or the Assignee under the Purchase Agreement; or (ii) expand upon or limit the respective rights, benefits, responsibilities and obligations of the Assignor or the Assignee provided in or under the Purchase Agreement. To the extent the terms and provisions of this Agreement conflict with the Purchase Agreement, the terms and provisions of the Purchase Agreement shall control.


