CONFIRMATORY TRADEMARK ASSIGNMENT

This Confirmatory Trademark Assignment (“Assignment”) is effective as of October 18, 2023, by and between Delin Ventures Advisors Limited, a private limited company of the United Kingdom with an address located at 15 Stukeley Street, 1st Floor, London, WC2B 5LT, United Kingdom (“ASSIGNOR”), and Swarm Oncology Limited, a private limited company of the United Kingdom with an address located at 15 Stukeley Street, 1st Floor, London, WC2B 5LT, United Kingdom (“ASSIGNEE”).

WHEREAS, ASSIGNOR had adopted, used, was using, and was, to the best of its knowledge and belief, the owner of the trademark listed in Schedule A, attached hereto and incorporated herein by this reference, and all other rights appurtenant thereto, including, but not limited to, all common law rights, trade name rights, and the right to recover for past infringement (the “Trademark”);

WHEREAS, ASSIGNOR had acquired goodwill associated with and symbolized by said Trademark and had not abandoned the same;

WHEREAS, ASSIGNEE was desirous of acquiring all rights, title, and interest in and to the Trademark;

WHEREAS, ASSIGNOR was willing to assign to ASSIGNEE all rights, title, and interest as ASSIGNOR had possessed in and to the Trademark;

WHEREAS, ASSIGNOR was a successor to the relevant portion of ASSIGNOR’s business, which was ongoing and existing, and which pertained to the Trademark; and

WHEREAS, ASSIGNOR, for good and adequate consideration, did assign and sell to ASSIGNEE, as of the effective date of this Assignment, all rights, title, and interest as ASSIGNOR did possess in and to the Trademark set forth in **Exhibit A**, together with the goodwill symbolized with said Trademark concurrent with the transfer of certain tangible assets as indicia of said goodwill, as set forth in the Business and Asset Sale Agreement previously entered into between ASSIGNOR and ASSIGNEE.

NOW, THEREFORE, for good and adequate consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby confirms its assignment and sale to ASSIGNEE of all rights, title and interest as ASSIGNOR possessed or may possess in and to the Trademark set forth in Schedule A, together with the goodwill symbolized by said Trademark concurrent with the transfer of certain tangible assets as indicia of said goodwill. The assignment included the relevant portion of ASSIGNOR’s business, which was ongoing and existing, to which the Trademark pertained.
