The Initial Close Security Agreement was recorded with the United States Patent and Trademark Office on October 4, 2021, at Reel/Frame numbers 7474/0001.

C. G. As described in the Trademark Security Agreement dated as of January 31, 2023, executed by Peak 15 Systems, Inc. in favor of the Collateral Agent (the "*Peak 15 Security Agreement*"), Peak 15 Systems, Inc. granted to the Collateral Agent, for the ratable benefit of Lenders, a security interest in and lien on, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Peak 15 Security Agreement). The Peak 15 Security Agreement was recorded with the United States Patent and Trademark Office on January 31, 2023, at Reel/Frame 7957/0169.

H. As described in the Trademark Security Agreement dated as of April 28, 2023, executed by Recur360 Software LLC in favor of the Collateral Agent (the "*Recur360 Security Agreement*", together with the Initial Close Security Agreement, the PM Attendant Security Agreement, the March 2022 Security Agreement, the April 2022 Security Agreement, the July 2022 Security Agreement and the Peak 15 Security Agreement, each a "*Security Agreement*" and, collectively, the "*Security Agreements*"), Recur360 Software LLC granted to the Collateral Agent, for the ratable benefit of Lenders, a security interest in and lien on, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Recur360 Security Agreement). The Recur360 Security Agreement was recorded with the United States Patent and Trademark Office on April 28, 2023, at Reel/Frame 8055/0367.

I. The Grantors requested that the Collateral Agent enter into this Release in order to effectuate, evidence and record the release and reassignment to each Grantor of any and all right, title and interest that the Collateral Agent, on behalf of itself and Lenders, may have in the Trademark Collateral (as defined in the Security Agreements, as applicable) pursuant to the Security Agreements.

3. Release of Security Interest. The Collateral Agent, on behalf of itself and Lenders, hereby terminates each Security Agreement and hereby terminates, releases and discharges any and all security interests that it has pursuant to each Security Agreement in any and all of each Grantor's right, title and interest in, to and under the Trademark Collateral, and hereby reassigns to each Grantor any and all right, title and interest that it may have, in, to and under the Trademark Collateral, including certain trademarks described in Exhibit A. The Collateral Agent has executed this Release in favor of the Grantors as of the Effective Date.

4. Further Assurances. The Collateral Agent agrees, at the Grantors' expense, to take all further actions, and provide to each Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantors and their successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.

5. Governing Law. The validity and interpretation of this Release shall be governed by and construed in accordance with the substantive laws of the State of New York (without reference to conflict of law principles).
