RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this “*Release*”) is made as of November 22, 2023 by OBSIDIAN AGENCY SERVICES, INC., in its capacity as collateral agent (in such capacity, the “*Collateral Agent*”) for the Lenders (as defined in the Credit Agreement referred to in the Intellectual Property Security Agreement (as defined below)), in favor of the Grantor (as defined below).

WITNESSETH:

WHEREAS, QUORA, INC., a Delaware corporation (the “*Grantor*”), executed that certain Intellectual Property Security Agreement, dated as of April 12, 2019 (as amended, restated, supplemented or otherwise modified from time to time, the “*Intellectual Property Security Agreement*”) in favor of the Collateral Agent, pursuant to which the Grantor granted a security interest to the Collateral Agent in certain trademarks and other intellectual property of the Grantor;

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office at Reel: 6941; Frame: 0309 on May 18, 2020; and

WHEREAS, the Collateral Agent has agreed to terminate the Intellectual Property Security Agreement and terminate and release the entirety of its security interest in all Collateral (as defined in the Intellectual Property Security Agreement), including all its liens on the trademarks and trademark applications of the Grantor identified on Annex 1 attached hereto and made a part hereof, and to reconvey any and all of its rights, title and interests in, to and under the Collateral to the Grantor.


NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, the Collateral Agent hereby terminates the Intellectual Property Security Agreement and the security interest and absolutely, unconditionally and irrevocably terminates, releases, cancels and discharges the collateral pledges, grants, liens and security interests granted by the Grantor in favor of the Collateral Agent (on behalf of itself, the Lenders and their permitted successors and assigns) in and to the Collateral and all rights, title and interests in, to and under the Collateral, all without warranty or representation of any kind.

This Release shall be governed by, and construed in accordance with, the law of the State of California.
