RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Agent agrees as follows:

1. Agent hereby unconditionally and expressly releases, terminates, cancels, and extinguishes any and all of its right, title, and interest in and to any and all pledges, grants, liens, and security interests it may have upon the Trademarks and Patents in favor of the Grantor. Agent also hereby unconditionally and expressly releases, terminates, cancels, and extinguishes any and all of its right, title, and interest in and to any and all pledges, grants, liens, and security interests it may have upon any copyrights, domain names, and social media accounts in favor of the Grantor.
2. This Release shall be binding upon Agent's legal representatives, assigns and successors.
