Release of Lien on Trademarks

This **Release of Lien on Trademarks** ("**Release**") is made by The Bank of Nova Scotia, as administrative agent (in such capacity, "**Agent**"), in favor of Weston Foods US, LLC, an Indiana limited liability company (now known as WB Frozen US, LLC, a Delaware limited liability company) ("**Grantor**").

WHEREAS, pursuant to a certain General Security Agreement, dated as of December 10, 2021 (the "**Security Agreement**") among Grantor, Agent, and others party thereto, and a certain Trademark Security Agreement dated as of December 10, 2021 (the "**Agreement**") made by Grantor in favor of Agent, which Agreement was recorded with the United States Patent and Trademark Office on December 10, 2021 on reel 07525 frame 0565, Grantor granted to Agent for the benefit of the Secured Parties (as defined in the Security Agreement) a lien on and security interest in, all of its right, title and interest in, to and under the trademarks set forth on Schedule A hereto (the "**Released Trademarks**"), along with (i) all renewals and extensions of the Released Trademarks, (ii) all goodwill of the business connected with the use of, and symbolized by, each Released Trademark, (iii) to the extent accruing on or after the date of this Release, all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the Released Trademarks, including, without limitation, all rights to sue and recover at law or in equity for any infringement, misappropriation or violation of the Released Trademarks accruing on or after the date of this Release (collectively, the "**Specified Released Trademark Collateral**").

WHEREAS, Agent desires to release its lien on and security interest in the Specified Released Trademark Collateral, including those trademarks set forth on Schedule A hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent does hereby release its lien on and security interest in the Specified Released Trademark Collateral, including those trademarks set forth on Schedule A hereto and reassigns to Grantor all right, title and interest of Agent in, to and under the Specified Released Trademark Collateral, including those trademarks set forth on Schedule A hereto.


