SECURITY AGREEMENT

GRANT OF SECURITY INTEREST (TRADEMARKS)

The undersigned, **THOROGOOD SPORTS LTD**, a limited liability company incorporated in the United Kingdom (the “Grantor”) is obligated to **GLAS TRUST CORPORATION LIMITED**, as Security Agent (“Secured Party”), and has entered into the Supplemental Debenture dated July 26, 2023 (“Supplemental Debenture”), which is supplemental to the Debenture dated November 23, 2021 (as amended, supplemented or otherwise modified from time to time, the “Original Debenture,” and together with the Supplemental Debenture, the “Agreement”), in favor of the Secured Party. Capitalized terms used herein and not otherwise defined are defined as set forth in the Original Debenture or Supplemental Debenture, as the case may be.

Pursuant to the Agreement, the Grantor granted to the Secured Party a security interest in and to all of the right, title and interest of the Grantor in and to the trademarks listed on Schedule 4 of the Original Debenture, which trademarks are registered in the United States Patent and Trademark Office and the intellectual property specified in any Security Accession Deed and any trademarks, service marks, business and trade names, design rights, confidential information, trade secrets, knowhow and other intellectual property rights and interests, whether registered, pending registration or unregistered, and the benefit of all applications and rights to use such assets in which any Grantor may from time to time have an interest as may exist throughout the world in each case for their full term and any extension thereto (the “Trademarks”), together with the goodwill of the business symbolized by the Trademarks, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof (the “Collateral”), to secure the prompt payment, performance, and observance of the Amended Secured Obligations (as defined in the Agreement).

For good and valuable consideration, the receipt of which is hereby acknowledged, and for the purpose of recording the grant of the security interest as aforesaid, the Grantor does hereby further assign to the Secured Party, and grant to the Secured Party a security interest in, the Collateral to secure the prompt payment, performance, and observance of the Amended Secured Obligations (as defined in the Agreement).


