**ASSIGNMENT OF TRADEMARKS

Assignor assigns to Assignee all of its rights, title, and interest in and to the Mark, including but not limited to U.S. Registration No. 1,071,549 and any and all common law rights in the trademark shown in U.S. Registration No. 1,071,549, together with the goodwill of the business associated therewith and symbolized thereby, and together with all rights appurtenant thereto, including, but not limited to, all common law rights, if any, causes of action, all interests, claims and rights for damages, profits and other awards by reason of any past infringement, dilution, misappropriation, or other violation thereof, and the right to sue therefor.

2. Assignor agrees to perform all reasonable and proper additional acts and to execute any additional documents at the request of Assignee which may be required to transfer all of Assignor's rights, title and interest in and to the Mark and/or the rights appurtenant thereto to Assignee, its successors or assigns.
