TRADEMARK ASSIGNMENT

This Assignment of Trademark (the "Assignment") is made by and between GT GLOBAL VENTURES, LLC (hereinafter "Assignor"), a Florida Limited Liability Company, whose address is 239 2nd Avenue S. 2nd Floor, St. Petersburg, FL 33701, and GT VENTURES, LLC, a Nevada Limited Liability Company, whose address is 2891 The Peaks Ln, Las Vegas, NV 89138 (hereinafter "Assignee").

Whereas, Assignor is the owner of the trademarks as described in Exhibit A attached hereto and incorporated by reference herein (the "Marks");

Whereas, Assignor is willing to assign its entire rights and interest in and goodwill of the Marks to Assignee.

Now, therefore, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:

1. **Assignment:** Effective **July 11, 2023**, Assignor hereby assigns, sells, and transfers to Assignee all of its rights, title, and interest in and to the Marks, including, but not limited to:
 - a. all registration rights with respect to the Marks;
 - b. any and all goodwill associated with the Marks;
 - c. any and all rights to prepare derivative marks;
 - d. the right to prosecute any pending trademark applications in Assignee's own name, where applicable;
 - e. the right to any registration that may issue from said trademark applications issued in Assignee's name, where applicable;
 - f. the right to apply in Assignee's own name for registration of the Marks in any and all countries;
 - g. the right to record title in any and all registrations that may issue upon the pending or other applications for registrations in the name of Assignee, where applicable;
 - h. the right to maintain existing and future registrations to the Marks; and,
 - i. the right to enforce in Assignee's own name for past, present, or future infringements.

2. **Assignor's Representations:** Assignor represents and warrants that:
 - a. Assignor is the exclusive owner of the Marks;
 - b. Assignor possesses all rights, title, and interest in and to the Marks;
 - c. Assignor has the power to enter into this Assignment;
 - d. the Marks do not infringe on the rights of any other person or entity; and,
 - e. the Marks and rights transferred in this Assignment are free of any lien, encumbrance, or adverse claim,



and giving full effect to this Assignment.

4. **Binding Effect:** The covenants and conditions contained in this Assignment shall apply to bind the Assignor, Assignee, their heirs, legal representatives, successors, and permitted assigns.
5. **Governing Law:** This Assignment shall be governed by and construed in according with the law of the state of Nevada.


