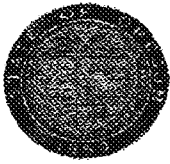

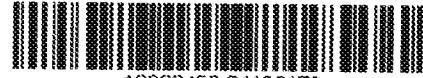

ARTICLE 8
OPTIONAL PROVISIONS

CORPORATION: Emagineered Solutions, Inc. ("Corporation")

INITIAL DIRECTORS. The initial directors of the Corporation are:

Stephen T. Waring, Chairman

Joyce A. Waring

Grant T. Waring

SHAREHOLDER ACTION WITHOUT A MEETING. Any action required or permitted by the Oregon Business Corporation Act ("Act") to be taken at a shareholders' meeting may be taken without a meeting if (a) the action is taken by shareholders having not less than the minimum number of votes that would be necessary to take such action at a meeting which all shareholders entitled to vote on the action were present and voted; (b) the shareholder action is evidenced by written consent describing the action taken that is signed by all shareholders taking such action; and (c) the signed consent is delivered to the Corporation for inclusion in the minutes or filing with the corporate records. The Corporation must give written notice of any action taken pursuant to this provision to all shareholders who did not consent to such shareholder action in writing by signing such written consent. The notice provided to such shareholders must contain or be accompanied by the material required by ORS 60.211.

LIABILITY OF DIRECTORS. No director of the Corporation shall be personally liable to the Corporation or its shareholders for monetary damages for conduct as a director; provided this provision shall not eliminate the liability of a director for any act or omission for which such elimination of liability is not permitted under the Act. No amendment to or repeal of this provision shall apply to or have any effect on the liability of any director of the Corporation for any act or omission that occurs before the effective date of any such amendment or repeal. No amendment to the Act that further limits the acts or omissions for which elimination of liability is permitted shall affect the liability of a director for any act or omission that occurs before the effective date of such amendment. If Oregon law is amended to authorize the further elimination or limitation of the liability of directors, then the liability of a director of the Corporation shall be eliminated or limited to the fullest extent permitted by Oregon law, as so amended.

INDEMNITY. The Corporation shall indemnify a director or an officer made party to a proceeding as the result of the individual being or having been a director or an officer of the Corporation to the fullest extent permitted by the laws of the State of Oregon now in effect or later amended.
