**TERMINATION AND RELEASE OF
FIRST SUPPLEMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT
(Trademarks)**

This TERMINATION AND RELEASE OF FIRST SUPPLEMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Termination and Release") is granted as of December 4, 2023 by SILICON VALLEY BANK, A DIVISION OF FIRST-CITIZENS BANK & TRUST COMPANY (successor by purchase to the Federal Deposit Insurance Corporation as receiver for Silicon Valley Bridge Bank, N.A. (as successor to Silicon Valley Bank)), as administrative agent (the "Assignee"), in favor of Stitch Fix, Inc. (the "Grantor").

WHEREAS, the Grantor executed and delivered a First Supplement to Intellectual Property Security Agreement dated as of June 2, 2021 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "Grant") granting the Assignee a security interest in and lien on certain trademarks and trademark applications ("Trademarks") described therein, which was recorded with the United States Patent and Trademark Office ("USPTO") on June 2, 2021, at Reel 7314, Frame 0155;

WHEREAS, the Grantor has requested that the Assignee hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantor in, to and under all of the Trademarks as herein provided; and

WHEREAS, the Grantor has requested that the Assignee provide a document suitable for recording with the USPTO to evidence the release of the Assignee's security interests in and liens on the certain Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby:

1. terminates the Grant and releases, terminates and discharges fully all liens and security interests in the Grantor's right, title and interest in, to and under the Trademarks, and all goodwill associated therewith, including, without limitation, those certain Trademarks identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded at the USPTO.


The Assignee agrees to provide Grantor with the information and additional authorization reasonably required or desirable to effect the release of the Trademarks described herein.
