**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Termination and Release”), dated as of December 5, 2023, is made by GLAS Americas LLC, as collateral agent for the Secured Parties (in such capacity, including any successors thereto, the “Collateral Agent”).

WITNESSETH:

WHEREAS, pursuant to the Credit and Guaranty Agreement, dated as of December 7, 2020 (as amended, restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), by and between, among others, Penney IP LLC, a Delaware limited liability company (the “Grantor”), the Lenders from time to time party thereto and the Collateral Agent, the Lenders have severally agreed to make extensions of credit to the Borrowers upon the terms and subject to the conditions set forth therein;

WHEREAS, pursuant to the Trademark Security Agreement, dated as of December 7, 2020 (the “Trademark Security Agreement”), a security interest (collectively, the “Security Interest”) was granted by the Grantor to the Collateral Agent in certain collateral, including the Trademark Collateral;

WHEREAS, the Trademark Security Agreement was submitted for recording with the United States Patent and Trademark Office on December 8, 2020 at Reel/Frame 7126/0544; and

WHEREAS, the Collateral Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral, including those trademarks listed on Schedule 1 hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Collateral Agent hereby agrees as follows:

1. Definitions. Capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement or the Credit Agreement, as applicable.
2. Release of Security Interest. The Collateral Agent, without representation, warranty or recourse, hereby terminates, releases and discharges any and all Security Interest in the Trademark Collateral, and any right, title or interest of the Collateral Agent in such Trademark Collateral shall hereby cease and become void.
3. Recordation. The Collateral Agent authorizes the Grantor and its designees to record this Termination and Release with the United States Patent and Trademark Office or any other applicable governmental authority at the Grantor’s expense.


4. Further Assurances. The Collateral Agent, at the Grantor's expense, hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the security interest release contemplated herein.

5. Governing Law. THIS TERMINATION AND RELEASE SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
