NOW, THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged by each Party, the Parties agree as follows:

Assignor hereby irrevocably assigns to Assignee all of Assignor’s right, title, and interest in and to the Marks, as well as variations thereof used by Assignor in the past that include or incorporate the Marks or elements thereof along with all the goodwill of the business(es) embodied therein and symbolized thereto and the trademark applications and registrations therefor, and any registrations resulting therefrom, free and clear of all liens, claims, charges, and encumbrances of any kind whatsoever. This assignment includes the right to take legal action and recover for past infringements thereof and to enjoin future infringements, together with all of Assignor’s goodwill and common law rights connected with the use of and symbolized by the Marks, as well as all existing registrations of the Marks and trademark applications for registration of the Marks, as detailed in Exhibit A hereto.

Assignor hereby covenants, agrees, and undertakes to execute all confirmatory assignments, lawful oaths, and any other papers which Assignee may reasonably deem necessary or desirable for securing to Assignee or for maintaining for Assignee the Marks, the applications, and all other rights assigned herein. Assignor agrees not to dispute or challenge or assist any person or entity in disputing or challenging rights in and to the Assignee’s rights in the Assigned Marks.
