**TERMINATION AND RELEASE OF SUPPLEMENT NO. 1 TO
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF SUPPLEMENT NO. 1 TO INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “**Termination and Release**”) is granted as of December 12, 2023 by **CANADIAN IMPERIAL BANK OF COMMERCE**, its subsidiaries and affiliates (including all such secured parties, collectively, the “**Bank**”), in favor of **CONFIANT INC.**, a Delaware corporation (the “**Grantor**”). Capitalized terms used herein without definition shall have the meanings respectively ascribed to them in the Agreement (as defined below).

WHEREAS, the Grantor executed and delivered the Supplement No. 1 to Intellectual Property Security Agreement, dated as of February 23, 2023 (the “**Agreement**”), granting to the Bank a security interest in all of its right, title and interest, whether presently existing or hereafter acquired, in, to and under the Intellectual Property Collateral, notice of which was recorded with the United States Patent and Trademark Office (“**USPTO**”) on February 23, 2023 at Reel 007983, Frame 0450.

WHEREAS, the Grantor has requested that the Bank hereby terminates, releases and discharges fully its security interests in and liens on all right, title and interest of the Grantor in, to and under all of the Intellectual Property Collateral as herein provided; and

WHEREAS, the Grantor has requested that the Bank provide a document suitable for recording with the USPTO to evidence the release of the Bank’s security interests in and liens on the Intellectual Property Collateral as herein provided.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby:

1. without recourse, representation or warranty of any kind, (a) terminates the Agreement and (b) releases, terminates and discharges fully all liens and security interests thereunder in the Grantor’s right, title and interest in, to and under the Intellectual Property Collateral, including, without limitation, the Trademarks set forth on Schedule A hereto; and
2. authorize and request that this Termination and Release be recorded with the USPTO.
