RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

WHEREAS reference is hereby made to that certain Intellectual Property Confirmatory Security Agreement dated as of July 29, 2020 (the "Agreement") among Joseph Ribkoff Inc. (the Grantor) and The Toronto-Dominion Bank, as administrative agent (the Secured Party);

WHEREAS the Grantor is the registered owner of (i) the Canadian trademarks and trademark applications and the Canadian copyrights listed in Schedule "A" hereto (collectively, the Canadian IP), and (ii) the United States trademarks listed in Schedule "B" hereto (the US Trademarks and together with the Canadian IP, the Intellectual Property);

WHEREAS, pursuant to a deed of hypothec entered into on December 1, 2017, referred to in the Agreement, a hypothec and a security interest were granted by the Grantor to the Secured Party, as administrative and collateral agent, in certain collateral, including without limitation the Intellectual Property;

WHEREAS the Agreement was recorded at the Canadian Intellectual Property Office ("CIPO") against the Intellectual Property with the Trademark Division on December 22, 2020 under file number 1946534 and with the Copyright Division on April 29, 2021 under number 1179647;

WHEREAS the Agreement was recorded at the United States Patent and Trademark Office ("USPTO") against the Intellectual Property on December 5, 2020 under Reel/Frame number 7124/0189;

WHEREAS the Secured Party now desires to confirm the termination and release of its security interests in and to the Intellectual Property;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Secured Party hereby:

1. Fully and irrevocably terminates and cancels the Agreement and releases, terminates and discharges, and reassigns to the Grantor, any and all liens, security interest, right, title and interest of the Secured Party in, to and under the Intellectual Property and to any other intellectual property covered by the Agreement, whether or not listed on Exhibit A and Exhibit B hereto;
2. Authorizes and requests that this Release of Security Interest in Intellectual Property be recorded at CIPO and at USPTO, and any similar or equivalent office in any other jurisdiction; and
3. This Release of Security Interest in Intellectual Property may be delivered by facsimile, email or other means of electronic transmission.



