## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of December 12, 2023 (this “Release”), is made by Alter Domus (US) LLC (as successor-by-appointment to The Northwestern Mutual Life Insurance Company), as Administrative Agent (“Administrative Agent”) in favor of HeartLand, LLC, a Delaware limited liability company (the “Grantor”).

WHEREAS, pursuant to that certain Second Lien Pledge and Security Agreement, dated August 30, 2019 (as amended, modified, extended or restated from time to time, the “Security Agreement”) by and among the Grantor, Administrative Agent, and other parties party thereto, the Grantor granted to the Administrative Agent, for the benefit of the Lender Parties, a continuing security interest in any and all right, title and interest of the Grantor in and to all Trademarks; and

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered to Administrative Agent, for the benefit of the Lender Parties, that certain Trademark Security Agreement dated as of September 24, 2021 which was recorded at the United States Patent and Trademark Office (“USPTO”) on September 24, 2021 at Reel 7431 Frame 0560 (the “TSA”).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of the Lender Parties, and the Grantor agrees as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement.

SECTION 2. Termination and Release. Administrative Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in any and all right, title and interest of the Grantor in and to the Trademarks listed on Schedule A attached hereto (collectively, “Released Trademarks”), granted pursuant to the Security Agreement or TSA;

(b) assigns, transfers and conveys any and all right, title or interest of the Administrative Agent in such Released Trademarks to the Grantor; and


(c) authorizes the recordation of this Release with the USPTO at the Grantor’s expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.


