NUNC PRO TUNC TRADEMARK ASSIGNMENT

This NUNC PRO TUNC TRADEMARK ASSIGNMENT is effective as of December 26, 2012 by and between The Endurance International Group, Inc., a Delaware corporation duly organized under the laws of Delaware (“**Assignor**”), with a principal address at 10 Corporate Drive, Burlington, MA 01803 and Bluehost Inc., a Utah corporation duly organized under the laws of Utah (“**Assignee**”), with a principal address at 1958 South 950 East, Provo, UT 84606.

WHEREAS, Assignor owns the entire right, title and interest in and to the trademark registrations and trademarks, and all common law rights associated therewith, that are listed in Schedule A attached hereto and incorporated herein by reference (collectively, the “**Marks**”); and

WHEREAS, The Britannia International Group, Inc. (“**Britannia**”), a Delaware corporation, and Assignee were wholly-owned subsidiaries of Assignor; and

WHEREAS, Britannia merged into Assignee on December 26, 2012, pursuant to which the Assignee is the surviving corporation (the “**Merger**”); and


WHEREAS, pursuant to the Merger, Assignor agreed to assign to Assignee all of the right, title, and interest in and to the Marks, and Assignee agreed to accept said assignment effective December 26, 2012.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor hereby assigns, transfers, and conveys to the Assignee, and the Assignee hereby accepts from the Assignor, all of the rights, title, and interests of the Assignor in and to the Marks, together with the goodwill of the business symbolized by the Marks, to be held and enjoyed by the Assignee for its own use and benefit and the use and benefit of its successors, assigns, licensees, or other legal representatives, together with the right to sue and recover for damages and profits and all other remedies for past infringements thereof.


