INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT (as from time to time amended, modified, restated, supplemented and in effect, this “Security Agreement”) is entered into as of December 29, 2023, by The Caden Companies, LLC, a California limited liability company (the “Grantor”), to and in favor of Compass Group Diversified Holdings LLC, a Delaware limited liability company (“Secured Party”).

Reference is made to (i) that certain Credit Agreement, originally dated as of September 16, 2010, among THE ERGO BABY CARRIER, INC., a Hawaii corporation (“Borrower”), ERGO BABY INTERMEDIATE HOLDING CORPORATION, a Delaware corporation (“Co-Borrower”), and COMPASS GROUP DIVERSIFIED HOLDINGS LLC, a Delaware limited liability company (together with its successors and permitted assigns, “Lender” or “Secured Party”), as amended by that certain First Amendment to Credit Agreement dated as of November 17, 2011, that certain Second Amendment to Credit Agreement dated as of March 28, 2012, that certain Third Amendment to Credit Agreement dated as of September 30, 2013, that certain Fourth Amendment to Credit Agreement dated as of September 28, 2015, that certain Fifth Amendment to Credit Agreement dated as of May 11, 2016, that certain Sixth Amendment to Credit Agreement dated as of June 9, 2016, that certain Seventh Amendment to Credit Agreement dated as of June 1, 2018, that certain Eighth Amendment to Credit Agreement dated as of March 31, 2019, that certain Ninth Amendment to Credit Agreement dated as of February 23, 2022, and that certain Tenth Amendment to Credit Agreement dated as of December 22, 2022 (and as may be further amended from time to time, the “Credit Agreement”) and (ii) that certain Guarantee and Collateral Agreement, originally dated as of September 16, 2010, as amended by that certain Joinder to Guarantee and Collateral Agreement dated as of May 11, 2016, that certain Joinder to Guarantee and Collateral Agreement dated as of November 13, 2020, and that certain Joinder to Guarantee and Collateral Agreement dated as of the date hereof (as the same may be further amended, supplemented or otherwise modified from time to time, the “Guarantee and Collateral Agreement”), each among the Secured Party, the applicable grantors (including the Grantor) and other parties thereto.

Pursuant to the Guarantee and Collateral Agreement, Grantor has granted a security interest in its Collateral (as defined therein) to the Secured Party, which Collateral includes the Trademarks and Patents identified herein.

For good and valuable consideration, the receipt of which is hereby acknowledged, Grantor and Secured Party agree as follows:

Section 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Security Agreement, including its preamble and recitals, have the meanings provided or provided by reference in the Guarantee and Collateral Agreement.

Section 2. Grant of Security Interest. As security for the full and timely payment, observance and performance of the obligations pursuant to the Guarantee and Collateral Agreement, Grantor hereby grants to Secured Party a continuing security interest in and a right of setoff against, all of Grantor’s right, title and interest in the Trademarks and Patents (listed on Schedule A hereto).

Section 3. Purpose. This Security Agreement has been executed and delivered by Grantor for the purpose of recording with the United States Patent and Trademark Office (“USPTO”) the grant of a security interest in the Trademarks and Patents pursuant to the Guarantee and Collateral Agreement. The Guarantee and Collateral Agreement (and all rights and remedies of Secured Party thereunder) shall remain in full force and effect in accordance with its respective terms. In the event of any conflict between this Security Agreement and the Guarantee and Collateral Agreement, the Guarantee and Collateral Agreement shall prevail.

Section 4. Acknowledgment. Grantor hereby further acknowledges and affirms that the rights and remedies of Secured Party with respect to the security interest in the Trademarks and Patents granted hereby are more fully set forth in Guarantee and Collateral Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein.

Section 5. Filing this Security Interest. The party that files this Security Agreement with the USPTO shall: (i) complete accurately, and include as part of such filing, the USPTO's “Recordation Form Cover Sheet” for trademarks and patents and shall indicate on such cover sheet that the nature of the conveyance is a security interest; (ii) provide the other party hereto with copies of such filings; and (iii) pay all applicable filing fees.


Section 6. Counterparts. This Security Agreement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.
