TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this "Trademark Assignment Agreement") is dated as of December 17, 2023, by and between Bias Brewing, LLC, a Montana limited liability company (the "Assignee"), and Copperwood Brewing, LLC, a Montana limited liability company (the "Assignor").

RECITALS

WHEREAS, Assignor currently owns the trademarks listed in Schedule 1 hereto, together with all goodwill associated therewith, and all applications, registrations and renewals in connection therewith (the "Trademarks");

WHEREAS, Assignor desires to assign to Assignee all of Assignor's rights in and to the Trademarks, and Assignee desires to obtain such rights; and

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties to this Trademark Assignment Agreement hereby agree as follows:

Section 1. Assignment and Assumption

. Effective as of the date hereof, Assignor hereby conveys, assigns, transfers and delivers to Assignee, free and clear of all Liens, all of Assignor's right, title and interest in and to the Trademarks, together with (a) all income, royalties, damages and payments related thereto, (b) the right, if any, to register, prosecute, maintain and defend the Trademarks before any public or private agency or registrar, (c) the right to bring actions, defend against or otherwise recover damages or other compensation for past, present or future infringements, dilutions, misappropriations, or other violations thereof, including the right to sue and obtain equitable relief in respect of such infringements, dilutions, misappropriations and other violations, and the right to fully and entirely stand in the place of Assignor in all matters related thereto, and (d) any and all goodwill associated therewith.

Section 2. Ownership; No Challenge

. Assignor hereby acknowledges and agrees that from and after the date hereof, Assignee shall be the exclusive owner of the Trademarks. Assignor agrees that it will not at any time, directly or indirectly, challenge or assist any Person in challenging, in any jurisdiction (a) Assignee's rights, title and interest in and to the Trademarks, (b) Assignee's and its Affiliates' rights to use and control the Trademarks, or (c) the validity of the Trademarks.

Section 3. Cooperation

. This Trademark Assignment Agreement has been executed and delivered by Assignor for the purpose of recording the assignment herein with the appropriate government entity. Assignor agrees that at any time and from time to time Assignor shall promptly execute and deliver all further instruments and documents which Assignee, its successors and/or assigns

may reasonably request and at the cost of Assignee and its successors and/or assigns to effect the terms of this Trademark Assignment Agreement and to perfect, protect or more fully evidence Assignee's and its successors' and/or assigns' respective right, title and interest in and to the Trademarks, including, without limitation, its recordation in relevant U.S. and foreign local, state and national trademark offices.

Section 4. Governing Law

. This Trademark Assignment Agreement and any claim or controversy hereunder shall be governed by and construed in accordance with the laws of the State of Montana.

Section 5. Counterparts

. This Trademark Assignment Agreement may be signed in counterparts (including electronically) with the same effect as if the signatures to each counterpart were upon a single instrument, and all such counterparts together shall be deemed an original of this Trademark Assignment Agreement.
