RELEASE OF SECURITY INTEREST BY DECLARATION

This Release of Security Interest by Declaration (this "Declaration") is effective as of December 1, 2023 pursuant to the fulfillment of the underlying obligations.

I, William Tomaszewski, do declare as follows:

I am the General Counsel and Secretary of Wine.com, LLC (f/k/a eVineyard, Inc.) (the "Grantor").

1. Pursuant to (i) that certain Intellectual Property Security Agreement, dated as of May 4, 2001, by and between the Grantor and Sand Hill Capital Special Purposes, LLC (the "May 2001 Security Agreement"), and (ii) that certain Security Agreement, dated as of May 2, 2002, among the Grantor and Flying Disc Investments, L.P. (the "May 2002 Security Agreement" and, together with the May 2001 Security Agreement, each a "Security Agreement" and, collectively, the "Security Agreements"), the Grantor granted a security interest in and to all of Grantor's right, title, and interest in and to one or more of the trademarks set forth on Schedule A attached hereto (such trademarks, the "Trademarks").
2. The Security Agreements describe Grantor's grant of the security interest in and to the Trademarks listed in each Security Agreement. The May 2001 Security Agreement was recorded at the U.S. Patent and Trademark Office (the "PTO") on September 14, 2001, at Reel/Frame 2465/0320. The May 2002 Security Agreement was recorded at the PTO on May 10, 2002, at Reel/Frame 2464/0738.
3. To the best of my knowledge, the obligations secured under each Security Agreement (collectively, the "Obligations") were satisfied. The Grantor has repaid all its outstanding loans and/or other Obligations in connection with each Security Agreement in full.
4. Grantor hereby requests the PTO to record the release of the security interest in and to the Trademarks granted by Grantor under each Security Agreement.
5. The undersigned, being hereby advised that willful false statement and the like so made are punishable by fine or imprisonment, or both, under 18 U. S. C. 1001, declares that the facts set forth in this Declaration are true; all statements made of her own knowledge are true; and all statements made on information and belief are believed to be true.
6. The undersigned has personal knowledge of these facts and attests to their truth.





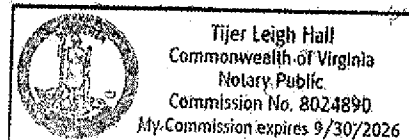
