RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is dated as of January 11, 2024 (the "Effective Date"), by ENTERPRISE BANK & TRUST, as Agent ("Agent"), in favor of TEAM Wolf Holding, LLC, a Delaware limited liability company and TEAM Wolf Operating, LLC, a Texas limited liability company (each, a "Grantor" and collectively, the "Grantors").

WHEREAS, pursuant to the Patent Agreement, Agent, through a certain Notice of Grant of Security Interest in Patents dated as of May 19, 2016, recorded in the United States Patent and Trademark Office on June 15, 2016, at Reel 038918, Frame 0433, established a lien and security interest to the Patents owned by Grantors as identified on Schedule A;

WHEREAS, pursuant to the Trademark Agreement, Agent, through a certain Notice of Grant of Security Interest in Trademarks dated as of May 19, 2016, recorded in the United States Patent and Trademark Office on June 15, 2016, at Reel 005814, Frame 0849, established a lien and security interest to the Trademarks owned by Grantors as identified on Schedule B;

WHEREAS, Agent wishes to release, discharge, relinquish, terminate, and dissolve its security interest in and continuing lien on all of Grantors' right, title, and interest in, to, and under the Patents and Trademarks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged Agent agrees as follows:

1. Agent hereby unconditionally and expressly releases, terminates, cancels, and extinguishes any and all of its right, title, and interest in and to any and all pledges, grants, liens, and security interests it may have upon the Patents and Trademarks in favor of the Grantors.
2. This Release shall be binding upon Agent's legal representatives, assigns, and successors.
