**ARTICLES OF CONVERSION OF  
FIRST HOSPITAL LABORATORIES, INC.**

Pursuant to Title 13.1, Chapter 9, Article 12.2 of the Code of Virginia, the undersigned, on behalf of First Hospital Laboratories, Inc., a Virginia corporation (the "*Corporation*"), states as follows:

**Article I.** The name of the Virginia corporation immediately before the filing of these articles of conversion is First Hospital Laboratories, Inc. The Corporation shall convert to a Virginia limited liability company and its name shall be First Hospital Laboratories, LLC (the "*LLC*").

**Article II.** The Corporation was originally incorporated on December 6, 1988 as a corporation with the name First Hospital Laboratories, Inc.

**Article III.** The plan of conversion, pursuant to Section 13.1-722.10 of the Code of Virginia, is set forth as follows:

- A. The full text of the articles of organization of the resulting limited liability company as they will be in effect upon consummation of the conversion is attached hereto as Exhibit A.
- B. Upon the filing of these articles of conversion (the "*Effective Time*"), and in accordance with the plan of conversion, the outstanding shares of the Corporation held by the sole shareholder of the Corporation (the "*Shareholder*") will be converted and exchanged for a membership interest in the LLC, which membership interest will constitute 100% of the membership interests of the LLC and will be equal to the proportional ownership of the Corporation held by the Shareholder immediately prior to the Effective Time. In addition, at the Effective Time, (1) the Corporation will cease to be a corporation and will continue in existence as the LLC, (2) the title to all real estate and other property or assets owned by the Corporation will continue vested in the LLC without reversion or impairment, (3) all liabilities and obligations of the Corporation will continue as liabilities and obligations of the LLC, and (4) any claim existing or action or proceeding pending by or against the Corporation may be continued as if the conversion did not occur, all as set forth in the plan of conversion. The conversion will not affect the liability or absence of liability of the Shareholder for any acts, omissions, or obligations of the Corporation made or incurred prior to the Effective Time. The cessation of the existence of the Corporation in the form of a corporation will not constitute a dissolution or termination of the Corporation.

**Article IV.** The plan of conversion was approved by the unanimous consent of the Shareholder on December 27, 2023.

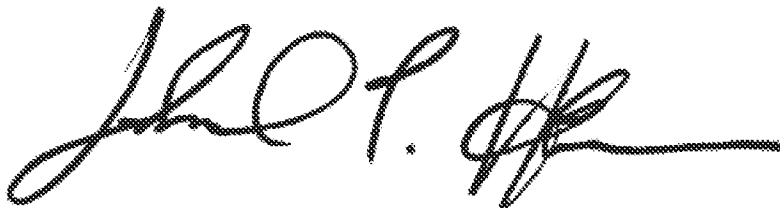
