WHEREAS the Assignor is the proprietor of the trademark registrations listed in Annex 1 (hereinafter "the **TRADEMARK(s)**").


WHEREAS The Assignor has agreed to assign the **TRADEMARKs** to the Assignee on the terms set out in this agreement

Agreed Terms



- (c) the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action (including passing off) arising from ownership, of any of the **TRADEMARKs** whether occurring before, on or after the date of this agreement.
