RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, pursuant to that certain Trademark Security Agreement, dated November 26, 2019 (the “**Trademark Security Agreement**”) recorded in the United States Patent and Trademark Office (“**USPTO**”) at Reel 6806, Frame 0317, Sportech, LLC (formerly known as Sportech, Inc.), a Minnesota limited liability company (“**Releasee**”) granted to Cerberus Business Finance Agency, LLC, a Delaware limited liability company (“**Releasor**”), as collateral agent for itself and the other Secured Parties, a continuing security interest in all right, title and interest of Releasee in, to and under the trademarks and service marks listed on Schedule A attached hereto (excluding, for clarity, any intent-to-use trademark applications for which an amendment to allege use or statement of use has not been filed under 15 U.S.C. § 1051(c) or 15 U.S.C. § 1051(d), respectively, or if filed, has not been deemed in conformance with 15 U.S.C. § 1051(a) or examined and accepted, respectively, by the USPTO), which trademarks and service marks are registered or applied for in the USPTO (the “**Trademarks**”) together with, among other things, the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the “**Collateral**”); and


WHEREAS, Releasee has requested, and Releasor wishes to provide a document suitable for recording in the USPTO for purposes of recording the release, relinquishment and discharge of its security interest in the Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.
2. Release of Security Interest. Releasor, without representation, warranty or recourse, hereby releases, relinquishes, terminates, cancels and discharges its continuing security interest in the Collateral, including without limitation, its continuing security interest in the Trademarks.
