NUNC PRO TUNC TRADEMARK ASSIGNMENT

WHEREAS, ASSIGNOR represents and confirms that prior to the Effective Date of this Assignment, ASSIGNOR had adopted, used, was using or using through a licensee, or intended to use, or use through a licensee, and was, to the best of its knowledge and belief, the owner of the trademark set forth in Schedule A, attached hereto and incorporated herein by this reference, and all other rights appurtenant thereto, including, but not limited to, all common law rights, trade name rights, causes of action, and the right to recover for past infringement (“Trademark”) where ASSIGNOR had used, applied for, and/or registered the Trademark.

WHEREAS, ASSIGNOR acquired goodwill associated with and symbolized by said Trademark and had not abandoned the same;

WHEREAS, ASSIGNOR represents and confirms that prior to the Effective Date of this Assignment, ASSIGNOR owned the trademark registration as set forth in Schedule B, attached hereto and incorporated herein by reference (“Registration”);

WHEREAS, ASSIGNEE desired to acquire all rights, title, and interest in and to the Trademark and Registration, and any other registered or unregistered trademarks owned or used by ASSIGNOR or any of its licensees or predecessors in interest which include or are comprised of the Trademark, together with the goodwill, which is ongoing and existing, symbolized by said Trademark;

WHEREAS, ASSIGNOR was willing to assign to ASSIGNEE all rights, title, and interest as ASSIGNOR may possess in and to the Trademark and Registration, and any other registered or unregistered trademarks owned or used by ASSIGNOR or any of its licensees which include or are comprised of the Trademark, together with the goodwill, which is ongoing and existing, symbolized by said Trademark; and

WHEREAS, ASSIGNOR did assign, convey, transfer, set over and grant, and wishes to confirm its assignment, conveyance, transfer, set over and grant to ASSIGNEE, as of the Effective Date of this Assignment, all rights, title, and interest as ASSIGNOR did possess in and to the Trademark and Registration, along with the goodwill, certain tangible assets as indicate of said goodwill, and the relevant portion of the business to which the Trademark pertain.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNOR hereby acknowledges and confirms the assignment to ASSIGNEE of all rights, title, and interest as ASSIGNOR may possess in and to the following:

- (a) the Trademark set forth in Schedule A;

(b) the Registration set forth in Schedule B; and


(c) any other registered or unregistered trademarks owned or used by ASSIGNOR or any of its licensees which include or are comprised of the Trademark;


